

Amended Covid-19 Building Guidelines

In accordance with new CDC guidelines, our in-house mask protocols for owners are as follows:

- ~ FULLY VACCINATED OWNERS CAN CHOOSE TO <u>WEAR</u> MASKS OR <u>NOT</u> <u>WEAR</u> MASKS WHEN THEY ARE TRAVELING TO AND FROM THEIR APARTMENTS.
- ~ THOSE WHO CHOOSE TO NOT WEAR MASKS MUST REGISTER THEIR VACCINATION STATUS WITH THE EXECUTIVE OFFICE VIA EMAIL OR HARD COPY.
- ~ PLEASE BE RESPECTFUL OF EVERYONE(s) CHOICE(s) BY NOT CONGREGATING IN THE LOBBY OR PUBLIC SPACES WITHOUT WEARING A MASK, AND DO NOT ENTER THE ELEVATOR IF YOU SEE ANOTHER TENANT IN THE ELEVATOR WHO IS WEARING A MASK.
- ~ GUESTS WILL STILL BE REQUIRED TO WEAR MASKS AT ALL TIMES WHEN OUTSIDE APARTMENTS
- ~ FOR NOW, MASKS WILL STILL BE REQUIRED IN THE GYM FOR ALL REGARDLESS OF VACCINATION STATUS.

New Key to NYC Mandate

Dear Tenant~ Shareholder,

In keeping with the NYS
Governor's new mandate any
visitors (12 and older) coming to
enter the building will be required
to show proof of vaccination
status. These include:

NYS Excelsior pass
NYS covid vaccination app
Vaccination card (hardcopy)
CDC vaccination card
Other official vaccination record

Please note, a negative Covid test is not sufficient.


